Notice of Changes in Representative Director, Directors and Corporate Auditors and Appointment of an Executive Officer

DESCENTE LTD. (the "Company") hereby announces that, at the Board of Directors' meeting held on March 25, 2019, following changes in the Representative of Director, Board of Directors and Corporate Auditors as of June 2019 were resolved. These changes will be officially decided at the Annual General Meeting of Shareholders scheduled to be held in June 2019 and at the subsequent Board of Directors' Meeting.

And the Company plans to enter into an agreement with ITOCHU Corporation ("ITOCHU") regarding the management structure that was resolved for this time, the Company's future management policies, establishment of the corporate governance structure and so forth as soon as possible.

1. Outline of the Agreement

The outline of the agreement that the Company and ITOCHU will enter into is as follows.

(1) Purpose

To build and maintain a constructive cooperative relationship between the Company and ITOCHU to enhance the corporate value of the Company.

(2) Content

- i) Management Policy and Philosophy of the Company
- * It is set as the corporate philosophy "To bring the enjoyment of sports to all."
- * Continue to provide high-value-added products through collaboration and alliances with a wide variety of business partners, based on the "craftmanship" we have cultivated over many years as our source of competitiveness.
- * Build and maintain a workplace environment and corporate culture in which the Company employees who support the "artisanship" can demonstrate the Company's founding spirit "Creation, Challenge, Integrity and Harmony" and work energetically.
- ii) Management Structure of the Company
- * Establish a management structure that enables sustainable, medium to long term improvement in corporate value and independent management for the common interests of shareholders.
- * In order to achieve this, the Board of Directors of the Company will consist of 2 people from the Company, 2 people from ITOCHU (who will retire from Itochu and then be rehired by the Company in principle), and 2 independent outside directors.
- * Candidates for Outside Directors shall be independent from the Company and its related parties and be nominated through fair deliberation by the Nominating Committee of the Company from those who are recommended by any incumbent Director or Corporate Auditor.
- * Establish a fair and impartial Nominating Committee including independent outside Directors as an advisory body to deliberate matters related to the appointment and dismissal of directors.
- * Formulate and implement a successors development plan to develop the next generation of senior management and conduct regular reviews by the Nominating Committee.
- iii) Protection of General Shareholders of the Company
- * Hold continual and constructive discussions and dialogues with ITOCHU and other shareholders to enhance the Company's corporate value while giving consideration to the common interests of shareholders.
- * Give sufficient consideration to the interests of general shareholders and ensure substantial equality and fairness among shareholders.

* Regularly report to the Board of Directors' Meeting on the status of transactions with major shareholders and other related parties and, if deemed necessary and appropriate, to give due consideration to procedures such as consultations with independent outside directors and to disclose information.
